# **Hugo Acciarri**

Hugo Acciarri is a Professor of Law and of Law, Economics and Behavior at the National University of South, Bahía Blanca, Argentina, where he chairs its Program of Law, Economics and Behavior. He is also a post-graduate professor at the University of Buenos Aires, Argentina.

He authored and edited books and chapters of books in the field of Law and Economics published in North and South America, as well as in Europe, and research papers on Tort Law, Contract Law, Consumer Law, Litigation, Compliance, Law and Economics and Behavioral Law and Economics.

As a visiting scholar and visiting professor, he taught courses, seminars, and lectures, and presented research at the Universities of Harvard; Columbia; California, Berkeley; Chapman, Los Angeles; Paris I (Panthéon-Sorbonne), Paris-Sud (presently, Paris-Saclay); Autónoma, Complutense, Carlos III, Madrid, Pompeu Fabra, Barcelona (Spain), Autónoma (México), among many others.

He received the 2008 Microsoft Research Award for Scholarship on Law and Economics and the 2010 Life Achievement Award for Development in Law & Economics in Latin America (University of California, Berkeley and ALACDE) among others.

The University San Martín de Porres (Lima, Perú), conferred the title of Honorary Professor on him in 2010. He was also elected to the National Academy of Law and Social Sciences, Córdoba, Argentina in 2013.

He was appointed as President of the Latin American and Iberian Law and Economics Association (2013-2017).

# Maria José Azar-Baud

Maria José is an expert in Collective redress in Comparative law. Associate Professor at University of Paris-Saclay and lecturer at several national and international Universities, namely University Paris 1 Panthéon-Sorbonne (Consumer Dispute Resolution) and Paris 2 Panthéon-Assas (European Union Consumer law), at Masters' degree, her main areas of teaching and research are Consumer law, International Contracts and Comparative procedural law.

Maria José holds a double PhD from Paris 1 Panthéon-Sorbonne University

and the University of Buenos Aires focusing on Collective actions in Consumer law in France and Argentina, under a Comparative Law perspective. The French editor Dalloz published her thesis in 2013.

She is the author of more than 100 contributions in three languages, mainly related to class



actions, collective, representative and group actions, in the fields of procedural law, torts and liability, consumer law, environmental law and discrimination. As a member of several scholarly institutions, Maria José has been heard in matters of group and collective actions in general in the Senate, the National Assembly and several agencies in France, as well as in the European Parliament, as one of the main authors of the Study on Collective redress in the EU Member States requested by the European Parliament (http://www.europarl.europa.eu/RegData/etudes/STUD/2018/608829/IPOL STU(2018)608829 EN.pdf).

Maria José co-chairs the Institut Droit Éthique Patrimoine (IDEP) and the Paris-Saclay Legal Clinics. She founded the Observatory of Group Actions and other forms of Collective Redress (www.observatoireactionsdegroupe.fr) in 2017, an international platform for researchers and practitioners aimed at collecting data related and analysing it from an interdisciplinary point of view.

She began her career as a lawyer at the Bar of Buenos Aires and has extensive experience in the practice of collective actions and the negotiation of amicable collective settlements on behalf of consumer associations in Argentina.

Currently, aside from lecturing, Maria José is an attorney-at-law at the Bars of Paris and of Buenos Aires, and as international counsel, she advices on mass disputes' resolution and seats at the Executive Board of two European non-profit organisations acting as plaintiffs in mass tort cases and seeking to grant access to justice on a collective scale.



### Alexandra Bensamoun

Alexandra Bensamoun is a professor of private law and criminal sciences at the University of Paris-Saclay/Evry, where she created and directs the Master 2/LLM «Fundamental Intellectual Property and Digital Technologies», in co-education with Laval University (Quebec) and the Autonomous University of Madrid (Spain). Appointed as a «qualified personality» at the CSPLA (Conseil Supérieur de la Propriété Littéraire et Artistique, French Ministry of Culture), where she led several missions - notably on the responsibility of technical intermediaries, on the right of communication to the public,

on artificial intelligence and culture, and on text and data mining -, she is also an expert for UNESCO on the 2005 Convention on the diversity of cultural expressions. She is the author of numerous individual and collective research projects, including a treatise on the law of artificial intelligence. Involved in research networks, she is vice-president of the French branch of ALAI (and member of the executive committee of the international association), associate researcher at OBVIA and member of the executive committee of the DATAIA Institute of Paris-Saclay University.



### Vilmos Bilicki

Dr. Vilmos Bilicki is an Assistant Professor at the University of Szeged's Department of Software Engineering, where he leads the Machine2Machine research group, consisting of around 30 students and researchers. With a Ph.D. in Information Science and Technology, he has over 90 scientific publications and has secured a European patent in telemedicine. Dr. Bilicki has spearheaded ten EU-funded FP6 and FP7 projects, as well as more than 20 industrial and R&D projects. He is a founding member of the Intelligent Medical Systems section of the Hungarian Scientific Association

for Infocommunications and holds nine patents, three of which are related to telemedicine.





### Pierre-Etienne Bouillot

From 2014 to 2022, he was assistant professor at AgroParisTech (Univ. Paris-Saclay) and researcher at the Institut de Recherche Juridique de la Sorbonne (IRIS).

Since September 2022, he holds the Junior Chair in Food Security Law at the Centre de Documentation et de Recherches européennes (University of Pau and the Adour Region).

His research activities focus on the law applicable to the agri-food sector, His project has two main focuses: the first on food safety, and the second

on the ecological transition of food systems.

### **Déborah Eskenazy**

Déborah Eskenazy is an Associate Professor at the Faculty of Pharmacy of Paris-Saclay University and a member of "GRADES" ("Groupe de recherche et d'accueil en droit et économie de la santé").

Déborah Eskenazy graduated from Paris Pantheon-Assas University obtaining a Master's degree in Comparative Law in 2009. She then graduated and practiced as a lawyer in a life sciences law firm. In 2012, she joined the legal department of the French National Authority for Health (HAS) and started a thesis on the legal framework of medical devices. She obtained

her PhD in Law in 2016 from Lille University. From 2016 to 2018, she worked within the legal department of the French Blood Establishment (EFS). She joined Paris-Saclay University in September 2018.

Déborah Eskenazy's primary research focuses on health products', and especially medical devices', legal framework. Her thesis was on the renewal of legal framework for medical devices resulting from the proposals of new regulations. Her publications and lectures at conferences are dedicated to topics related to regulatory but also liability and digital health.

She is director of a Master's degree on health products regulatory affairs and co-director of a Bachelor's degree on law, science and innovation and teaches law-related topics to the pharmacy students (industrial property, labour law, etc.)



### **Aude Farinetti**

Aude Farinetti is a lecturer in public law at Université Paris Saclay, specialising in environmental law and co-director of the M2 "Environmental Law". She defended her thesis on the legal protection of watercourses at the Université Jean Moulin Lyon 3 and has contributed to various research programmes on wetlands, environmental assessment, the proliferation of sargassum algae in Martinique and water quality.







### **Patrick Jacob**

Patrick Jacob is professor of international law at the university Paris-Saclay (UVSQ). He is co-director of the Master's Program on International and European Law. At Paris-Saclay, as well as in other academic institutions (Sciences Po and Paris 2), he teaches public international law and international economic law, with a special focus on international investment law. He has published extensively on various issues of international law, especially the law of international responsibility and international investment law. For two years, he acted as one of the co-convenor of the 3IPEP project, which

gathered teachers and researchers from three academic institutions (UVSQ, ULap (Rovaniemi, Finland) and RGSL (Riga, Latvia)) in order to tackle the legal issues raised by the existence and development of international investments affecting indigenous peoples and the environment, with a special focus on the arctic region.



# Kathryn Judge

Kathryn Judge is an expert on banking, financial innovation, financial crises and regulatory architecture. In her book Direct: The Rise of the Middleman Economy and the Power of Going to the Source (HarperBusiness), she uses the insights she gained from years of studying financial intermediation to explain broader shifts in the structure of the economy, the increasing power of intermediaries across numerous domains, and how these changes have contributed to new sources of fragility and undermined accountability.

Kathryn regularly presents her work to audiences in the United States and abroad, allowing her to engage with an array of policy makers, academics and industry leaders. Her academic work has received accolades from academic peers and industry. Her book Direct was on the longlist for the Financial Times Business book of the Year, among other accolades.

Kathryn currently serves as an editor of the Journal of Financial Regulation and a research member of the European Corporate Governance Institute. She previously served on the Financial Stability Task Force co-sponsored by the Brookings Institution and Chicago Booth School of Business as well as the Financial Research Advisory Committee to the Office of Financial Regulation. While serving on FRAC, she co-chaired the working group on financial innovation and the working group on the LIBOR transition.

Kathryn is currently the Harvey J. Goldschmid Professor of Law and Vice Dean for Intellectual Life at Columbia Law School. Prior to joining Columbia Law School, she clerked for Judge Richard Posner of the Seventh Circuit Court of Appeals and Justice Stephen Breyer of the Supreme Court. She also worked as a corporate associate with Latham & Watkins LLP. She is a graduate of Stanford Law School (J.D. with Distinction, 2004), where she earned the Urban A. Sontheimer Honor (second in class), and Wesleyan University (B.A. with High Honors, 1999).

# István Juhos

István Juhos is a senior research fellow at the University of Szeged and has collaborated with several prestigious research institutions in the EU, UK, Israel and China. He earned PhD in computer science with a research focus on artificial intelligence (AI) and the foundations of mathematics. He has been teaching university courses on AI and advanced computer science and mathematics for over fifteen years including AI and advanced programming techniques. As research and development director, he has led several pioneering science and technology projects including large-scale

ones with several million euros budget and involving more than thirty countries. Additionally, he has founded or co-founded technology startups and associations, making contributions to national priorities in European countries for instance in Germany, Norway and Hungary. He has published numerous papers, delivered talks and keynote speeches at various international conferences, scientific, governmental, corporate institutions and in the media. Moreover, he served as a chair or member of scientific committees of national and international scientific societies and journals.



# **Pierre Lequet**

Pierre Lequet is a Tenured Associate Professor of Law at Université Polytechnique Hauts-de-France. He is Director of the Master's Program on 'Real Estate Law and Finance'. He also teaches and lectures at other universities such as CY Cergy Paris University or Paris Sciences & Lettres University.

For more than ten years, Pierre devotes most of his research to environmental economic law. More precisely he wrote numerous articles

about corporate duty of care, sustainable consumer law, ecological impact of digital technology, Dieselgate in the context of contracual litigation and the protection of whistleblowers. He also works on issues more specifically related to business law. He is affiliated to expert associations such as Société Française de Droit de l'environnement.



# Véronique Magnier

Véronique Magnier is a full-time Professor of Law and the Deputy Director in charge of International relationships at the Graduate School of law of Paris-Saclay University.

She devotes most of her research to corporate law, corporate governance and business ethics from national, comparative, European and International perspectives. She is the co-author of the textbook 'Traité de Droit commercial-Ripert et Roblot-' (LGDJ ed., last ed. 2022), and the author of two monographies, one in English, « Comparative corporate

governance, Legal perspectives » (E. Elgar ed., 2017) and another in French: 'Déontologie et éthique d'entreprise (France University Press ed., 2023). She coordinated various books: 'La gouvernance des sociétés cotées face à la crise' (LGDJ, coll. Droit des affaires, 2010), 'Entreprise et développement durable' (Dalloz, 2013), 'Blockchain et droit des sociétés' (Dalloz, 2020), 'Commentaire article par article de la directive 2019/1937 sur les lanceurs d'alerte' (Kluwer-Larcier, 2023). She regularly participates in conferences in Europe, North America and Asia.



She is currently the co-Director of the Master's Program on 'Business, Tax and Financial Market Law', the founder of the Master's Program on 'Law, Entrepreneurship and Digital' (LEAD), of the international Program 'Law and Advisory', and of the Paris-Saclay legal clinics. She is also involved in annual Executive programs for business lawyers and judges. As an Adjunct Professor at Georgetown University Law center, she teaches an annual course for LLM international students, 'Comparative corporate governance', since 2010.

For ten years (2009-2020), Véronique was the director of a research institute at Paris-Saclay University, the Institute 'Droit Ethique Patrimoine'. As an active member of the board of directors of the NGO Transparency International France since 2014, she also participates in debates on draft legislation and supports companies in their compliance programs. She is affiliated to expert associations such as Société de Législation comparée, Trans Europe Experts, Institute for Corporate Governance.



# Marie Malaurie-Vignal

Marie Malaurie-Vignal is Full Professor at Paris Saclay University. She is the Scientific manager of the journal Concurrence Consumption Contracts (LexisNexis), Member of the IEJ Board of Directors of UVSQ University and of the scientific committee of the International Summer School of the University of Paris Saclay.

She is a Specialist in Economic law, competition law, distribution law and intellectual property law. She is the Author of books on competition

### Vincent Marcilhac

Vincent Marcilhac is a senior lecturer in cultural geography of food at CY Cergy Paris University. He is the Director of the Master's Program on 'Management in catering services and international hospitality'. He is the founder of the association GEOFOOD, which organizes seminars and scientific conferences in geography of food.

Vincent Marcilhac defended his thesis on 'The French food luxury' in 2011. He is the author of the book untitled 'Le luxe alimentaire: une singularité française' (Ed. PUR, 2012) and he coordinated various works, like 'Les

établissements de restauration dans le monde' (Ed. L'Harmattan, coll Géographie et cultures, 2012) and 'Les goûts du chocolat dans le monde' (Ed. L'Harmattan, coll. questions alimentaires et gastronomiques, 2019). He regularly participates in conferences in France or abroad. He is affiliated to an interdisciplinary research center named Heritage: Culture/s, Patrimony/ies, Creation/s (UMR 9022), working and publishing papers on the construction and the promotion of food and culinary heritage.



### **Ana Nordberg**

Ana Nordberg, is associate professor and senior lecturer in Civil Law at Lund University, Sweden. Dr. Nordberg specializes in intellectual property law, data and regulation of new or emerging technologies. Her research often explores intersections between fields of law in the context of ethical legal, social and policy implications of technologies and associated new business models and social phenomena.

Teaching Panel Synopsis: Proposal for a European Health Data Space EU Regulation (EHDS Act)

The European Health Data Space (EHDS regulation) proposes a health-specific data sharing framework intended to establish more detailed rules, common standards and practices, specific infrastructures as well as a governance framework for the use of electronic health data in the cross border treatment of patients (primary uses) but also for research, innovation, policy making, patient safety, statistics or regulatory purposes (secondary uses).

This panel will debate issues of privacy, consent and patient safety; as well as the possible implications for research and innovation in the healthcare sector.



#### **Daniela Piana**

PhD in sociology at the University of Paris IV Sorbonne in 2001. Jean Monnet Fellow (EUI° in 2003, Fulbright Fellow (UC Berkeley) in 2007, associate at the Institut des Hautes sur la Justice in Paris and at the Institute of social sciences of politics, ENS Paris Saclay. She coordinates «Just Europe», ICEDD Luiss. Member of the Observatory for the assessment of the impact of the reforms for the growth of the country, in the Cabinet of the Minister of Justice from 2014 to 2017. Currently a member of the OECD Research Conference On Justice carries out international research activities in collaboration with

the Société de Législation Comparée. Appointed in January 2019 member of the Office of Studies of the Council of State. Her research interests are at the crossroads of sociological and political disciplines and focus on the transformation of the rule of law, both in relation to social dynamics in multi-cultural societies, and in relation to the hybridization of languages - natural and artificial - is still related to the redefinition of the functional and territorial boundaries to which the law refers





### **Delphine Placidi-Frot**

Pr. Dr. Delphine Placidi-Frot is Full Professor in Political Science and International Relations at Université Paris-Saclay (France). She is currently Adjunct Vice-President for Research in Human and Social Sciences at the university, and co-director of Master programs in Political Science. She also supervises 2 Master diplomas in Political Science and International Relations (Governance of Sustainable Development Projects in Southern Countries and Diplomacy and International Negotiation). Her research expertise deals with diplomacy, foreign policy and negotiations, international organisations

(mainly within the United Nations system), international cooperation and One Health international governance.



# Miguel A. Ramiro Avilés

Miguel A. Ramiro Avilés is Associate Professor of Philosophy of Law at the University of Alcalá, where he is the Director of the Research Group 'Disability, Chronic Illness and Accessibility to Rights' (DECADE-UAH), which includes a legal clinic focused on legal literacy of people with HIV. He was previously Associate Professor at the Carlos III University of Madrid, where he was Deputy Director of the 'Bartolomé de las Casas' Human Rights Institute and Director of the Master's in Fundamental Rights.

Although he continues to make small forays into utopian political thought

(the subject of his doctoral thesis), his current line of research focuses on the rights-based response to HIV. 
