This Executive Diploma is offered by Université Paris-Saclay, in partnership with the United Nations Institute for Training and Research (UNITAR).

Its objective is to train experts capable of conducting economic assessments of international policies, anticipating geopolitical risks, and negotiating within major international organizations. The programme aims to strengthen the skills of professionals navigating complex diplomatic and international environments, with a strong focus on sustainable development, governance, scientific and technological diplomacy, as well as geopolitical and climate-related challenges.

It combines the academic excellence of Université Paris-Saclay with the practical expertise of UNITAR practitioners, offering a hybrid learning approach that blends theory, case studies, and simulations.

The diploma seeks to provide participants with comprehensive training on the economic, environmental, energy, and geopolitical dimensions of sustainable development, while developing practical skills in diplomacy, negotiation, strategic communication, and official document drafting. It aims to strengthen participants' ability to analyze, synthesize, and present complex information, integrate scientific and technological dimensions into policy decisions, apply adaptive strategies in uncertain contexts, and become familiar with the functioning of the United Nations system. Overall, the programme prepares participants to contribute effectively to international governance and the achievement of the Sustainable Development Goals (SDGs).

The programme adopts a multidisciplinary approach combining economics, energy, law, diplomacy, geopolitics, finance, climate studies, and data science.

The Economics, Energy and Development Diplomacy (EEDD) University Diploma is structured around :

- Online core curriculum 85 hours with Université Paris-Saclay
- Online core curriculum 40 hours with UNITAR
- 2 immersion weeks in Paris (3 days) and Geneva (3 days)

Each module is associated with one or more Sustainable Development Goals (SDGs) to anchor the programme within the 2030 Agenda.

LANGUAGE, DELIVERY MODALITIES AND DATES

The programme is designed as a **one-year university diploma** delivered in a **hybrid format**, with **English** as the language of instruction. The launch of the first cohort is scheduled for **Fall Semester 2026**.

Modules will be delivered through the **online learning platforms (LMS)** of UNITAR and Université Paris-Saclay for asynchronous components, using existing tools. Depending on decisions by module coordinators, **synchronous sessions** may be conducted via Zoom or other videoconferencing platforms.

Learning will integrate several dimensions:

- **Knowledge acquisition** (readings)
- **Practical application** (activities)
- **Exchanges and interactions** (discussion and collaboration)
- **Personal reflection** (application to individual experience)

All modules will prioritize **interactivity, practical relevance, and experience sharing**.

In-person sessions, when scheduled, will take place in **Paris and Geneva**.



ASSESSMENT AND VALIDATION METHODS

Assessment methods will vary by module and instructor and may include :

- Online MCQs and case studies
- Written examinations
- Simulations and role-playing exercises
- Immersion report and final oral presentation
- Validation through participation
- Continuous assessment (quizzes, practical cases, participation)
- Applied projects (simulated negotiations, economic reports, diplomatic briefs)

PROGRAMME CONTENT AND STRUCTURE

The joint **Executive Diploma** created by Université Paris-Saclay and UNITAR is designed as a **hybrid programme** (online and in-person), with **synchronous and asynchronous** online components. The programme combines **lectures, case studies, group work, and interactive sessions** to provide a rich and engaging learning experience.
